GENERAL RESERVATION TERMS

RESERVATION:

Season, per week: from Saturday 5.00 P.M to Saturday 10.00 A.M

Off season : 3 days minimum.

REQUIRED DEPOSIT:

The third of the rent amount by cheque or money order, by international money order for foreigners. You must send the deposit with the reservation.

- We have to reconsider our agreement if there's any change as regards the date or the number of people.

You must pay the balance of the rent amount on arrival.

You can enter the rental unit from 5.00 P.M.

You must leave the rental unit between 8.00 and 10.00 A.M at the latest.

- Definitively leaving the renting, each client must bring his/her key back at the reception and not give it to a friend or a neighbour. In any case, he/she can't give a third person the opportunity to benefit from the paid stay.

You should notice any arrival after 8.00 P.M .

THE RESERVATION WILL BE KEPT 24 HOURS AFTER THE DATE MENTIONED IN THE RENTAL CONFIRMATION. EXCEPT DELAY NOTICE FROM THE CLIENT.

- The tenant entering the rental unit a few days later must pay the total rent amount in advance.

COMPULSORY DEPOSIT OF 160€

An inventory has been made before your arrival. Once the rental unit entered, you must control it within the next two hours. After this time limit, you will be charged any noticed damage and we'll use the previous inventory to settle any disagreement.

In order to check the rental unit, it must be let clean and without personal things. If everything is right, you will be refunded your deposit according to the preliminary mode of payment.

VERY IMPORTANT:

Any client can be refused the renting and won't be refunded the deposit if he/she comes without PREVIOUS NOTICE TO THE MANAGEMENT

- with too many people,
- if the intended composition of the tenants is not respected,
- with an animal not insured or not totally clean.

RENTAL FORFEIT:

In case of termination of the agreement by one of the parties three months before the date determined for the occupancy of the renting the hereinafter clauses have been decided:

- Termination from the tenant: refund (less 50€ for charges for file)
- Termination from the owner: refund (plus 50€ as a compensation) of the amount of the deposit paid earlier.

**ANY CURTAILED STAY WON'T BE REFUNDED
WHATEVER THE REASON**

Any tenant leaving before or after the opening hours of the reception must let his/her deposit as a security.

If everything is right once the inventory made the deposit will be sent back within 48 hours.

On the contrary, if the rented places are DIRTY, DAMAGED with DAMAGED MATERIAL, an estimate will be sent to the client via a registered letter and a supplementation can be claimed if it exceeds the deposit.
